BCMUD is a MUD. What is a MUD?



A Municipal Utility District (MUD) is a type of local governmental entity. Other examples of local governmental entities include counties, cities, school districts, junior colleges, and drainage and flood-control districts.


A MUD is governed by a 5-person Board of Directors that is elected by the residents within the MUD. The Board's primary functions are to oversee the MUD's management, affairs, and operations; establish policies and adopt tax rates; and establish water, sewer, solid waste, and recreational fees and charges.

MUD taxes are levied and collected to finance the costs of public infrastructure improvements that serve residents of the District. They also pay for maintenance and operation costs not funded by retail rates and charges.

BCMUD's primary functions:

- Own and operate a Public Water Supply (PWS) system that treats and distributes drinking water to residents
- Own and operate a wastewater collection system to provide sewer service to District residents
- Own and operate a Managed Separate Storm Sewer System (MS4) drainage and stormwater facilities
- Own and operate parks and recreational facilities, including programs for District residents
- Provide street lighting and trash/recycling services



BCMUD, about us



- **Overview:** Established in 1977, the District is 48 years old, spans more than four square miles, and is home to more than 18,314 residents.
- **Utilities:** The District has a water intake facility that supplies an 11-mile raw water line, a Superior-rated water treatment/delivery system (60 miles), wastewater conveyance (60 miles), and a Municipal Separate Storm Sewer System (MS4).
- **Parks and Recreation:** Within the District's more than 300 acres of parkland are 15 parks, 8 playgrounds, 6 miles of trails, 5 pavilions, 4 pools, 3 tennis courts, 3 volleyball courts, a splash pad, a 65,000-square-foot community center, a Community Garden, greenbelts, 32 Karst Caves, and an 18-hole disc golf course. The District also runs leagues, camps, and extensive programming.
- **Customer Service:** The District facilitates **s**treet lighting, as well as trash and recycling services.
- **Employees:** The District employs more than 60 full-time, 80 part-time, and 90 seasonal team members.
- **BCMUD does NOT:** The District doesn't manage roads or sidewalks, provide fire protection, law enforcement, or electric power.



PARKS AND RECREATION COST RECOVERY AT 30%



PARKS AND RECREATION COST RECOVERY - EXPENSES




Measures taken to improve Cost Recovery:

- Committee engagement:
 - Parks and Recreation Advisory, and
 - Community Center Advisory.
- Utilization studies:


PARKS AND RECREATION COST RECOVERY - REVENUES

M&O PROPERTY TAX PROJECTED TO REMAIN FLAT Before 2014, the property tax "cap" was 8% on revenues before mandatory rollback elections, and In 2019, reduced to 3.5% for cities, counties, and developed MUDs by Senate Bill 2,


- Not a 3.5% cap on property tax revenue increase,
- A 3.5% cap increase to a single theoretical Average Residential <u>Homestead</u> property,
- The calculated tax rate is then applied to <u>ALL</u> properties, including both commercial and rentals,
- If appraisals rise significantly, tax rates can be expected to decrease.
- If appraisals fall significantly, tax rates can be expected to remain flat due to Homestead Cap Adjustments.

Without significant property valuation changes, the future year's Total M&O Property Tax Revenue is projected to remain relatively flat because the District is substantially built out, and there will be no tax revenues from additional development.

- In Fiscal Year 2024, there was a \$22,500 (0.3%) decrease.
- In the Fiscal Year 2025, there was a \$20,400 (0.2%) increase.

UTILITY RATES BASED ON COST-OF-SERVICE



The Texas Water Code, Section 13.043(j), requires rates to be 'just and reasonable'.

In 2014, with Senate Bill 567, the Texas Legislature transferred the agency that considers rate appeals from the Texas Commission for Environmental Quality (TCEQ) to the Public Utility Commission (PUC).


The PUC is intended to regulate utilities, ensuring fair rates, reliable services, and consumer protection.

The PUC follows a cost-of-service model that does not include expenses unrelated to utility services.

PUC rulemaking and rate cases have historically rejected rate structures that allocate costs beyond utility-related operations.

NEW PARKS MAINTENANCE FEE

The FY25 Fiscal Year budget includes a \$9.00-per-month fee* charged to residential and commercial connections based on the amount intended to fund the Parks Maintenance Cost Center, which provides for maintenance of the District's greenbelts, trails, playgrounds, restrooms, Karst features, Great Oaks medians, and tree replacements.

The fee started for residential customers on April 1, 2025.

The fee is shared by 6,590 residential and 92 commercial connections. This includes the total number of homes, apartment units in an apartment complex, townhome units, condo units, and businesses within the District.

*This new fee is equivalent to the cost of half a glass of milk a day.





NEW EMERGENCY MANAGEMENT AND HAZARD MITIGATION FEE

The FY25 Fiscal Year budget includes a \$0.75-per-month fee* charged to residential and commercial connections. The fee is based on the amount intended to fund hazard mitigation projects (such as the shaded fuel breaks in District green belts). It also helps develop a reserve to fund unanticipated emergency management and hazard mitigation services within the authority of a municipal utility district in the event of emergency circumstances, as determined by the District Board of Directors.

The fee started for residential customers on April 1, 2025.

The fee is shared by 6,590 residential and 92 commercial connections. This includes the total number of homes, apartment units in an apartment complex, townhome units, condo units, and businesses within the District.

*This new fee is equivalent to the cost of a tablespoon of milk a day.


